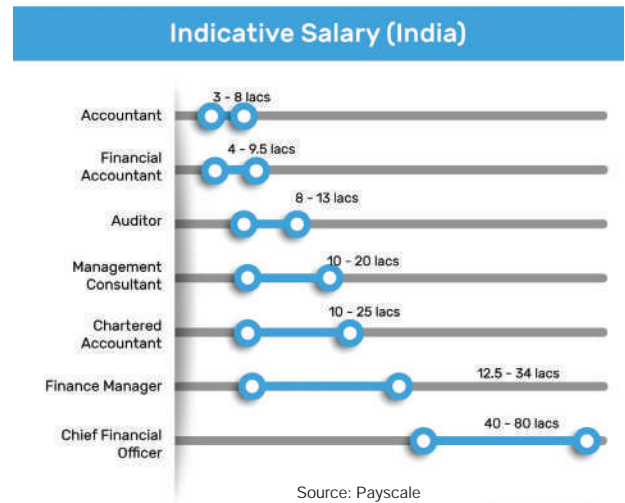

Knowledge level exams are 100% Objective and Computer Based Online exams. You get 2 hrs for a 100 mark question paper. Exams can be taken through out the year through on-demand Computer Based Exams.

Skills Level exams are 60% Descriptive and 40% Objective exams in written format. You get 3hrs for a 100 mark question paper. Exams can be taken in March, June, September, and December.

Professional Level exams are 100% Descriptive and case study based exams in written format. You get hrs for a 100 mark question paper. Exams can be taken in March, June, September, and December.


